## Cookies & monitoring

*A cookie is a small text file that we store on your device. Our website uses cookies to distinguish from other users of your website. Cookies also provide us with information about how this website is used so we can keep it as up to date, relevant and error-free as possible.*

- *Strictly necessary cookies – These are cookies that are essential to the operation of our website.*
- *Analytical/performance cookie – These cookies allow us to recognise and count the number of visitors to our website.*
- *Functionality cookies – These cookies are used to recognise you when you return to our website.*
- *Targeting Cookies – These cookies record your visit to our website, the pages you have visited and the links you have followed.*

*We may monitor traffic to our site and collect the following information:*

- *The IP address of your computer.*
- *The referring website from which you have got to our website from.*

*The reasons for this are:*

- *To make ongoing improvements to our website based on this data.*
- *To see our most popular sources of business.*

## Disclosure of personal data

*We may disclose your personal data:*

- *To other companies interested in your services*

### 4. Right to cancel

*You have the right to cancel the purchase of a good without having to give a reason at any time within the “cooling off period” of seven working days, beginning on the day after you receive the goods.*

*Once you have notified us that you wish to cancel the contract, any sum debited to us will be refunded to you as soon as possible and in any event within 30 days of your cancellation. After using our service for more than 7 days the money are not refundable.*

### 5. Notices

*All notices you send us must be sent to the contact details on [this site](#). We may give notice to you at either the email or postal address you provide to us when making a purchase. (Notice will be deemed received and properly served 24 hours after an email is sent or three days after the date of posting of any letter.) In providing the service of any notice, it will be sufficient to prove, in the case of a letter, that the letter was properly addressed, stamped and placed in the post and, in the case of an email that the email was sent to the specified email address of the addressees.*

### 6. Fees

Our fees are explained in the main menu and can be accessed [here](#). We have the right to change our fees without any notice. However, this will not affect existing clients, once you purchased a service we can't change the fee until after the period expired. For example if you purchase the “365 days” package we can't change the fee until the 365 days run out.

### 7. Accessing our site

Access to our site is permitted for free to the public, and we reserve the right to withdraw or amend the service we provide on our site without notice. Registered users have access to more services. We will not be liable if for any reason our site is unavailable at any time or for any period.

### 8. Submitting a listing, posting, reviewing or commenting
